Our Company had announced in the previous PDP statements that our Company had been declared as the winner of the tender, issued by the Romanian Bucharest Municipality, for the purchase of 100 units of 12 meters Electric Bus and Charging Units, providing the necessary charging infrastructure, garage administration and maintenance, and the contract would be signed after the completion of the procedures and processes stipulated in the relevant legislation; and regarding the said tender, the objection of a participating company was accepted by the objection authority, it was decided to reevaluate the tender, and our Company would take legal action against the relevant decision.

The litigation process of our Company against the decision of the appeal authority to accept the objection resulted in a negative result.

On the other hand, against the decision made by our Company as a result of re-evaluation by the contracting authority after the decision of the objection authority to accept the objection; this time, our Company made an objection application to the objection authority, which would result in the cancellation of the entire tender, and the examination of the said objection application is still ongoing.
